

Data Protection Policy pursuant to the General Data Protection Regulation (GDPR) European Data Protection Regulation No. 2016/679

Dear User,

For the purposes provided for in EU Regulation no. 2016/679 on the protection of individuals in terms of the processing of personal data, I hereby inform you that the personal data that you may have provided and acquired as a result of browsing the <u>www.verdesign.it</u> website will be processed in compliance with the regulations provided for in the aforementioned Regulation in accordance with the rights and obligations arising therefrom, and wish to inform you that the same data will be processed in accordance with the following principles:

a) PURPOSE OF THE DATA PROCESSING AND PROVISION AND REFUSAL

The sole purpose of data processing is the correct and complete execution of the existing contractual relationship with you, i.e., to receive your requests regarding commercial offers and services provided by VERDESIGN SRL. In the first instance, we would like to remind you that consent is compulsory and that refusal makes it impossible for the writer to continue the contractual relationship. In the second instance, we would like to remind you that the processing of your data is subject to your explicit consent and that you will therefore be asked to express this consent in the appropriate manner as set out in the Regulation.

b) PERSONAL DATA PROCESSING METHODS

The data is processed by means of operations carried out with or without the aid of electronic devices and consists of the collection, recording, organisation, storage, consultation, processing, modification, selection, extraction, comparison, use of interconnection, blocking, communication, cancellation and destruction of data. The Data Controller who will carry out these activities is specified in point e) below.

c) DATA COMMUNICATION

Personal data may only be disclosed to the Data Controller and may be communicated for the purposes referred to in point a): to external collaborators and, in general, to all subjects to whom communication is necessary for the proper performance of contractual obligations or to comply with legal requirements. Personal data is not subject to dissemination.

d) DATA STORAGE

The data is kept for the time required to fulfil the contract, and, in any case, will not be kept for more than 10 years, as required by current tax legislation.

The storage of the aforementioned data is thus carried out in compliance with the principles of minimisation contained in the aforementioned legislation. However, it is the user's right to ask the data controller to justify the duration of data storage by sending an email to the following address: info@verdesign.it

F) RIGHTS OF THE DATA SUBJECT

The data subject has the right (upon written notice to be sent by email to: info@verdesign.it):

- to access, rectify, erase, restrict and object to the processing of data

- to obtain without hindrance from the data controller the data in a structured, commonly used and machinereadable format for transmission to another data controller

- to withdraw consent to the data processing, without prejudice to the lawfulness of the processing resulting from the consent obtained prior to the withdrawal

- to lodge a complaint with the Data Protection Authority.
